CIRCULAR (SCHOLARSHIP)

Subject: "Merit-cum-Means Income linked Financial Assistance scheme".

Introduction:-

The Delhi Government proposes a "**Merit-cum-Means Income linked Financial Assistance scheme**" for providing tuition fee reimbursement under the aegis of Delhi Higher Education Aid Trust, with the aim to enhance greater access to high quality higher education for meritorious students from economically disadvantaged sections for the society.

Objective of scheme:-

The objective of the scheme is to extend financial assistance to the meritorious and needy students pursuing higher education in NCT of Delhi. Under this scheme the Delhi Higher Education Trust through Directorate of Higher Education (DHE), GNCTD will fully or partially reimburse the tuition fee paid by the students.

Eligibility Criteria:-

1. The student should have been enrolled for under graduate programme in any of the Delhi state public Universities or college/institutes affiliated to Delhi state public Universities.
2. The student should fulfill the income/economic and academic performance criteria as specified for each category mentioned below:-

Eligibility (Gross Annual Family Income of student from all Sources)	Qualifying Aggregate percentage (Marks in all Subjects)	Percentage of Financial Assistance
Category 1 Beneficiary under National Food Security scheme & possess the Card issued under the scheme	60%	100%
Category 2 Not covered under category 1 but whose family income is up to 2.5 lac per annum	60%	50%
Category 3 Family income above Rs. 2.5 lac per annum but not exceeding Rs. 6 Lac per annum	60%	25%

A relaxation of 5% in qualifying aggregate percentage of marks will be allowed to SC/ST category students.

8.	Cancelled Cheque/Passbook (Account must be in name of student and aadhaar seeded only)
9.	Copy of Aadhar Card
10.	Fee Receipt for current Academic Year
11.	Format "A" Declaration by the student
